COVID-19: Coronavirus Outbreak – Impact on Shipping *Update* 09/04/2020

In response to the 2019-nCoV novel coronavirus outbreak, a number of countries, ports and organisations are publishing details of the measures being put in place.

The below is a brief summary of information we have received so far that has the potential to impact ship operations.

Last updated: 9 April 2020

Country Informing party Date Summary of advice

			From 10 March 2020 Albania is officially in the list of affected countries with COVID-19. Up to now there are detected 64 cases with COVID-19 in Albania. The majority of cases are detected in Tirana (capital of the country). There are few cases detected in Durres city but up to now no reported cases are within the staff /employees of Durres Port Authority and/or other service providers acting in the port area.
			Restrictive measures, similar to those of other countries, are being imposed from the government. From 18:00 hrs to 06:00 hrs and from 10:00 hrs to 16:00 hrs there is movement curfew, and no one can be outside in the city (unless there are justifiable reasons) however the activity in the port (loading, discharging, formalities etc. are continuing as usually 24 hours).
Albania	Samer & Misa	19- Mar	Please note that cargo ships can be operated normally. For all the vessels that come to port the crew is not allowed to go out to shore and no embarking or disembarking of crew is possible.
			Actually in Durres port the cargo vessels continuing the normal operations. During this period usually only the ship agent (and the doctor) comes onboard to take the documents for the free pratique but as I said the crew is not allowed to go out ashore.
			At East Terminal (where the vessel is supposed to be berthed for discharging petcock) the commercial activity continuing normally. Considering the situation to date we believe that the members may bring the vessel normally at Durres port.

27 February: The port of Annaba notified all local agents that following the sanitary services advise, all vessels who called Italian ports will be put on quarantine on road till the release into free pratique is obtained.

29 March: all the Ports Authorities have prohibited the loading and the discharging operations between 01:00 hours and 07:00 hours in some ports and from 19:00 hours to 07:00 hours in other ports and the Algerian government has imposed the following precautionary measures:

- The Sanitary Authorities and the Coast Guards, board all the vessels at roads to check whether the ٠ vessel and the crew came from or transited through a contaminated country for at least the last 14 davs.
- Always at roads, the Health Authorities medically examine all crew members to ensure that they • show no symptoms or suffer from the corona virus, whether the ship came or not from a contaminated area.
- In the event, the crew presents no risk of contamination, the Authorities impose to all members to • wear masks and gloves as soon as the vessel berths.
- Crew cannot go ashore, unless requested by his service. •
- No one can board or leave the vessel if his temperature is above 38 °C or shows signs of breathing difficulties.

5 April: a curfew implemented has amended from 15:00 to 07:00 for Bejaia, Oran and Algiers.

MHSD (Medical Health Ship Declaration) Individual Health Declaration form & questionnaires form In case any crewmember or passengers present any sickness symptoms, free pratique will not be granted and vessel must comply the quarantine. In addition, Migration authorities has cancelled all temporary and working VISA for all citizens coming from affected area, i.e. China, Japan, South Korea, Iran, Europe, USA, Brazil and Chile (these two countries just recently added).

	Questionnaire		As a consequence, Vessels coming from ports abroad would be authorized to proceed alongside as long as they comply with special Sanitary requirements in force, such us crew health declaration, daily body temperature reports, details of crew changes that took place since Dec 1st 2019, copy of Medical logbook, Maritime health declaration and special questionnaire for detecting potential COVID-19 cases. Situation is being normalized at every port Area of Bahia Blanca, Necochea and Up River ports which were affected yesterday with some delays on berthing/ops. So far no delays registered due to Sanitary regulations.22 March: The Argentine Pilotage Chamber has advised that, from 0000 hours on 24 March, all vessels proceeding from Brazil and Chile must comply with a 14-day corresponding quarantine period as established by the National Government along with Sanitary Authorities. Ports in Brazil & Chile are considered as affected areas with exponential risks to spread Covid-19. This will cause delays/logistic changes in line-ups/commercial drawbacks depending on vessels' last known port of departure prior to entering Argentine jurisdiction.7 April: Pandi Liquidadores S.R.L advise that they provide an up to date COVID-19 section (www.pandi.com.ar). They summarise the current situation as follows:
			 Argentina is under a mandatory social isolation / quarantine which will be in place, in principle, until 13th April 2020 (after being extended from its original ending date). However, it is expected that after 13 April

restrictions will continue in place and would be lifted gradually, depending on the developments of the spread.

• The Government has considered that those activities which are urgent to enable international trade are exempted, therefore, ports and ships are operating. In principle, all ships calling Argentine ports must present specific pre-arrival information (72 hours before arriving) including the last 10 ports called, crew changes, ship's medical book, crew/passenger temperature records among others.

• Those ships which have called one of the areas considered specially affected by the outbreak (EU Members, Schengen Members, UK and North Ireland, USA, Korea, Japan, Iran, Chile and Brazil) would be subject to physical health inspection at Recalada Pilot Station (outer River Plate) by Coast Guards on behalf of health authorities. If the pre-arrival documentation on any ship, and the physical inspection for those calling from the "affected areas" do not reveal any Covid-19 case, or suspected case, the ship would in principle authorize to receive Pilots and proceed to port, where additional health inspections may take place. Otherwise the ship will be quarantined at the disposal of Health Authorities.

• Some ports have been affected by different players, such as unions, professional associations or locallybased authorities which request for any ship calling an "affected area" to have at least 14 days transit time since they departed from the last port. This would normally affect ships calling from Brazil – and Chile at some extent (due to short transit time). These ports are Necochea, Bahia Blanca, San Nicolas, Campana, Zarate, Rosario and San Lorenzo and other nearby ports may have the same tendency.

• Borders remain closed and there virtually no commercial flights. Therefore, crew changes or repatriations are not normally possible.

• Surveyors' attendance on board would be subject to the particular circumstances of the case, and the possibility for them to attend at port or on board may be limited. Not only due to the risk of contracting the virus, but also because the isolation is mandatory and its breach is being prosecuted criminally by our authorities.

• Courts and Administrative entities have entered into an extraordinary recess during the mandatory isolation. No activity is taking place thereon unless urgent and unavoidable.8 April: The port of Bahia Blanca is currently operating with no restrictions on LPG vessels or on vessels which have been at sea longer than 14 days and haven't called at affected areas.

			Since March 21, 2020 the government of Aruba implemented limited transportation from 21:00 to 06:00 hrs. some exceptions may apply with authorization. Sanctions were imposed for citizens who violate this provision.

		The Australian Government has announced that all persons entering Australia must undertake a precautionary self-isolation period for 14 days upon entry to the country. This applies to any person entering Australia, including Australian citizens and permanent residents. Persons who are entering Australia for less than 14 days must self-isolate for the entire duration of their stay. These measures apply to all people entering Australia including via aircraft and vessels. The travel restrictions for mainland China, Iran, the Republic of Korea and Italy remain in place for all travellers including maritime crew.

In practice, if a vessel has travelled for ten days since last being in a foreign port, the period of precautionary self-isolation for its crew members would be the remaining four days. Once the 14 days has elapsed and provided all crew are well and there is no sign of illness in any crew member, crew are permitted to take shore leave. Where a crew member is signing off a vessel (within the 14 day period) and remaining in Australia they must self-isolate at their accommodation for the remainder of the 14 day self-isolation period. Crew members departing Australia may proceed directly to the airport and depart; or they must self-isolation until the time they proceed to the airport.

Crew travelling to Australia (by aircraft) to join a vessel must adhere to the following arrangements:

- On arrival in Australia crew may take a domestic flight/s to their final destination to meet their vessel but must self-isolate at their accommodation if they have a layover at any time.
- Crew must proceed directly to the vessel or their accommodation.
- If not joining the vessel immediately, crew must self-isolate at their accommodation.
- Once on the vessel, crew members may leave the vessel to undertake vessel functions and must wear personal protective equipment while performing these functions.

International crew members joining a commercial vessel voyage are subject to a 14 day self-isolation period. Crew are permitted to transit through Australia but must remain in the port or airport, or self-isolate in accommodation for the duration of their transit. Crew must self-isolate at their final destination for the remainder of the 14 days.

Crew arriving in Australia are being urged to ensure they have a valid visa well ahead of their arrival, as the Department of Home Affairs Maritime Global Processing Centre (MGPC) will close for the Easter holiday from 4pm on Thursday 9 April until start of business on Tuesday 14 April. No Maritime Crew Visas (MCVs) will be processed during this period.

Applications for crew arriving in Australia on a vessel by sea should be lodged at least 14 days prior to departure from a port overseas in order to avoid any issues with delays to processing, crew travelling and/or arriving without visas, or associated punitive action.

This means applications should be lodged no later than Tuesday 24 March for crew intending to arrive in Australia from an overseas port between 9 and 14 April 2020.

The Australian Border Force will remain operational 24/7 basis over the holiday period.

Due to the coronavirus pandemic, travel restrictions are in place for all travelers to Australia. For the latest information on these restrictions <u>click here</u>.

23 March: Marine Safety Queensland (MSQ) and the Queensland State Government have softened their position in relation to the Port of Brisbane.

Due to different trade patterns for the port, it has been deemed appropriate to adopt the federal position for

the Port of Brisbane only (all other Queensland ports maintain the 14 day isolation policy for all vessels arriving from overseas).

This means that from Monday 23 March, vessels arriving at the Port of Brisbane, other than those arriving from China and South Korea, will be allowed to berth and commence cargo operations provided all nonessential crew remain on board and in self-isolation. Crew essential to the operations of the vessel will be permitted to carry out essential tasks provided they observe social distancing and wear appropriate PPE.

This is of course provided there is no sickness reported onboard.

Maritime crew may enter and depart Australia.

Maritime crew are not subject to the mandatory 14-day quarantine however, they will be required to comply with self-isolation requirements set out in this advice.

Maritime crew may be subject to additional state and territory controls.

6 April: All States and Territories have differing regimes regarding crew changes. However, as of 6 April, the following will apply in Western Australia:

- When a ship (commercial or passenger) arrives at a Western Australia Port from an overseas location where they have transited international waters they are required to enter quarantine for 14 days if they disembark the ship.
- Disembarkation occurs when the person leaves the area under control of the Australian Border Force (ABF). They may remain on the dock to facilitate the preparation of the ship for further sea operations.
- When they leave the area of the dock surrounding the ship they are deemed to have disembarked and come within the State Emergency Declaration at which point they are required to quarantine for 14 days.
- If they have not been at sea for 14 days since their last port of departure they are not allowed to disembark the ship without entering into quarantine for 14 days.

CURRENT EXCEPTIONS

If the voyage has been of a duration of 14 days or more since the last port of departure from an international destination and there is a crew change:

- An Authorised Person (Police /ABF) can provide a direction to the crew member to proceed to the nearest airport and depart immediately. (crew change / return to home)
- The crew member must have a ticket and travel directly to the airport.
- They are not to stop at any other locations and must follow all directions provided thereafter.

There are difficulties in procuring an international flight. Wherever possible, try to secure a direct international flight for departing crew rather than transiting through other Australian Airports. Restrictions on travel across State and Territory boundaries are currently in place and anyone crossing the border is required to enter into mandatory isolation at an approved facility / Hotel. It is unclear who is responsible for the costs of isolation.

Crew not allowed to come ashore, unless for urgent medical attendance. No crew changes are authorised.

- For the near future, whilst the Pilot remains obliged to inform on his name, he should not be mandated to sign any documents including;
 - o Security logs
 - o Pilot cards
 - o Master/Pilot exchange forms
- Only essential members of the crew are to be present in the wheelhouse during the conduct of the manoeuvre all of whom must sanitize their hands
- Crew members and Pilots should avoid touching their own faces
- Hand sanitizing material should be made available to Pilot and crew when on the bridge.

Pilots will not board incoming vessels arriving within the last fourteen (14) days from our government-listed high-risk countries. Any vessel that has visited countries with a high incidence of the COVID-19 virus, less than fourteen days ago, would not be boarded. Additionally, where any crew member has joined the vessel within the last fourteen (14) days, Pilots will not be permitted aboard until further information on the specific crew is obtained and analyzed. We thank you for your assistance and understanding and we work to keep our Pilots and your vessel's complement safe during these uncertain times.

7 April: Emergency Order, "Emergency Powers (COVID 19) (NO. 2) Order, 2020," was announced by Prime Minister and on March 31, Preventative restrictions are being enforced to prevent further spread of COVID-19, including:

No visitor shall be permitted to enter and disembark for any reason including transiting through The Bahamas.

- All airports throughout the entire Bahamas, including private airports and fixed-base operations (FBOs), shall be closed to all flights.
- All sea ports shall be closed to regional and international seafaring and private boating.
- Air and sea restrictions do not apply to: cargo flights or cargo ships, commercial courier flights, emergency medical flights or emergency flights approved by the Civil Aviation Authority.
- All international visitors currently in The Bahamas should be prepared to stay for an indefinite period of time.
- The citizen's movement is restricted except for those who have been deemed essential workers, or have special permission from the Commissioner of Police or for essential provisions.
- Proper social distancing guidelines of at least six feet (6ft.) must be followed at all times while outside the home.

27 March: The Department of Shipping, issued detailed guidance for ships calling at Chittagong, Payra and Mongla ports. It includes requirements and the Maritime Declaration of Health form which must be forwarded at least 72 hours prior arrival of the vessel at the port. If the maritime declaration of health given by the master is found to be incorrect and not reflecting the factual conditions of health of persons on board the vessel, the master is liable to be prosecuted as per applicable laws.

		20 March: The Benin government has decided to restrict entry and exit at its land borders, effective from 19 March. Only crossing judged necessary will be allowed. Quarantine will be automatically applied to any person attempting to not follow the restrictions.
		Visas will be restricted. Government reserved their rights to denied visa to any applicants as from now until further notice.

31 March: Proinde P&I advise that:

- Operations at Brazilian public and private ports and cargo handling facilities continue without disruptions other than the reduction of the labour force, particularly in administrative routines.
- Disinfection and heightened safety and health protocols are in place in most private and public ports.
- Despite the slowdown in the workforce in public administration and regulatory agencies, no significant problems related to the clearance and delivery of overseas cargoes have been sensed so far.
- Customs-bonded ports and terminals are operating without congestions beyond usual, while cargo transport in the cabotage and inland waterways remains undisturbed.
- On 26 March 2020, the government placed an exceptional 30-day ban, with immediate effect, on the disembark of all foreign crewmembers arriving at Brazilian ports and points of entry, except those seeking medical assistance or in an air connection to their country of origin.

In view of the temporary prohibition of entry by air of non-resident foreign nationals imposed on 27 March and beginning on 30 March 2020, embark of crewmembers in Brazil will also not be possible for at least the next 30 days.

2 April: Brazil P&I issue a circular is intended to provide guidance and recommendation regarding the acceptance of digitalized documents according to new Brazilian legislation, Decree 10.278, from 18 March 2020.

3 April, Promare reported on the impacts of Covid-19 in the Brazilian North and Northeast Ports of Brazil, highlighting that the cancellation of flights was beginning to impact on pilotage services in the North region, mainly in Santana, Santarém and Macapá. This issue will directly impact the grain and fertilizer market that use the logistics of the Northern Arc, due to probable delays on the port of Santarém.

The pilot company from Pilotage Zone 1 (UNIPILOT) has formally advised that in case there are no pilots available in Fazendinha (which is the entrance to the Amazon Port Region) for the manoeuvre towards the loading berth, the Shipping Agency requesting the service will have to pay for the chartered flight for the 2 pilots. After bringing the vessel to the inner anchorage/ berth, the 2 pilots will wait in the city for 36 hours in order to attend any immediate demands, such as shifting vessels to berth, unberthing to inner anchorage, or even bringing another vessel to Fazendinha to exit the Amazon Region. When the vessel operation is completed, if there are pilots available, they will board the vessel without extra costs. If not, there will be extra costs again to bring other 2 pilots for sailing procedures to the city. Pilotage information is that when the use of chartered flights is necessary, the costs will be relayed to the Owners/Charterers of the vessels. Estimated flight prices: *Belém/Macapá/Belém | Time of Flight: 00:50 | Cost: R\$ 13.318,00 Belém/Santarém/Belém | Time of Flight: 01:15 | Cost: R\$ 26.875,15 Macapá/Santarém/Macapá | Time of Flight: 03:15 | Cost: R\$ 49.140,00*

Due to all this situation, the schedule of manoeuvres of pilots in the North region, mainly in Santarém (at the CDP and Cargill terminals) is expected to suffer major delays.

12 March: Checks on board to be carried out by Border Health Inspectors. Agents requested to relay the Bulgarian state ban on crew coming ashore as well as contact between crew/passengers be limited to the bare minimum, till expiry of incubation period of 14 days. Cargo operations and repairs are allowed on the basis of minimal contact and obligatory PPE. In practice, there is no explicit requirement for ships to await the incubation period of 14 day at roads. There are no companies able to carry out disinfection on board.

- In the event that PHAC determines a crew member or passenger onboard a vessel to be at risk, notification will be provided to other (this may include but is not limited to the CBSA, CCG, TC Marine Safety, and appropriate pilotage and port authorities).
- Should a vessel have an ill or symptomatic crew member or passenger after having arrived in Canada, Masters should inform the appropriate local health authority and the ship's agent for further direction.
- Ships' agents are asked to inform the applicable pilotage authority of the state of the ship's health when requesting pilots for harbour movements or for the outbound passage.
- Vessel Masters with crew members and passengers symptomatic of the Coronavirus are to advise Transport Canada Marine Safety and Security following transmission of the 96 hour PAIR.
- Anyone who had close contact with someone who has or is suspected to have COVID-19 must selfisolate for 14 days. Self-isolate means that, for 14 days, they need to:
 - Stay at home (or aboard vessel) and monitor yourself for symptoms, even if mild

- Avoid contact with other people to help prevent transmission of the virus at the earliest stage of illness.

1 April: AqualisBraemar advise that:

- Canadian ports remain open. The Canadian government has confirmed the importance of the shipping industry as vital to the economy by keeping ports open and facilitating shipping activity. There are, however, precautions which must be taken.
- Drydock and repair facilities are working on reduced manning / split shifts to enable social distancing. Most remain open, but delays in repair and construction work are expected.

7 April: Transport Canada has issued a Ship Safety Bulletin giving guidance on the mobility of asymptomatic workers in the marine sector during the COVID-19 pandemic.

- Exemption is granted allowing Marine Sector Workers who have to travel to Canada to perform their duties, to board an international flight destined to Canada.
- No traveller can board a flight/enter Canada if they have a fever and cough or a fever and breathing difficulties.
- Asymptomatic crew are also permitted to transit to the nearest airport for the purpose of crew change-over.
- Anyone who has close contact with someone who has or is suspected to have COVID-19 must self-

isolate for 14 days. Operators should arrange local transport for crew members that avoids large groups, crowded areas, and public transit.

- For shore leave for seafarers onboard foreign vessels, at Canadian ports, terminals and marine facilities, until 30 June 2020, symptomatic and asymptomatic foreign nationals (except those exempted) may not enter Canada if shore leave is considered discretionary.
- Essential shore leave may be granted to an asymptomatic seafarer and is not to exceed four hours in duration.
- Crew onboard Canadian domestic vessels should follow the advice of their employer and local health officials.
- A complete ban on shore leave in the Canadian Arctic is in effect until December 31, 2020. Crews that are residents of Arctic and northern communities could be exempt.

18 February: The only preventive measures regard the protection of personnel at the country's immigration points.

Cargo Preparing

Some exported cargo could not be delivered to the loading ports in time due to transportation restriction in and out of Hubei Province. It is reported that China Council for the Promotion of International Trade would offer force majeure certificates to local companies, if they are unable to fulfil their international contractual obligations due to the coronavirus outbreak.

2 March: Guidance was issued by the MSA of the People's Republic of China on March 2, 2020: Operational Guidance for Ships and Seafarers for prevention and Control of COVID- 19 Epidemic. It is with reference to the WHO and IMO Guidance on the prevention and control of Novel Coronavirus (COVID-19) epidemic on ships, and based on the practical experience of shipping companies on the prevention and control of the epidemic. The Guidance aims to provide advice for the prevention and control of COVID-19 epidemic on ships and guidance for the personal protection of crew.

20 March: the Shanghai authorities responsible for such matters issued a notice regarding new requirements and procedures to be followed making it possible in certain circumstances for crew change to take place at Shanghai port.

For ships not arriving from a "severe outbreak" country, crew changes can be arranged in the normal manner. However, if the ship is arriving from a "severe outbreak" country, crew changes should be minimized as much as possible, but are still possible subject to necessary quarantine measures. Currently, 24 countries are on the "severe outbreak" list which includes South Korea, Italy, Iran, Japan, France, Spain, Germany, USA, UK, Switzerland, Sweden, Belgium, Norway, Denmark, Netherland, Austria, Australia, Malaysia, Greece, Czech Republic, Finland, Qatar, Canada, Saudi Arabia. This list is subject to update according to development globally.

31 March: AqualisBraemar advise that entry into China by foreigners is strictly prohibited including those with business visas, permanent residence status and green card holders (10 year visas) until further notice. All Chinese Nationals returning to China have to undergo 14 days quarantine. All expats and Chinese nationals must register for a QR Code that indicates there status in real time (updated to the minute). The QR Code categories are green (safe to travel and well / infectious free) orange (have travelled on same public transport or been in the vicinity of somebody who has been infected) or red (presently in 14 day quarantine but not yet showing symptoms, or have symptoms).

2 April: Oasis P&I advise on Chinese crew change requirements, setting out the procedures as follows:

Embarking crewmembers

- The ship owner needs to declare the embarking crewmember's health condition in the past 14 days to the local authorities where the crew change is going to take place and submit a Health Record Form together with the application.
- If the application is approved, then the ship owner can proceed and arrange embarkation.
- If the travel from the crewmember's living place to the ship is all in low risk areas, they can embark the vessel directly; otherwise they may need to be quarantined at the port for observation.

Disembarking crewmembers

- The ship owner also needs to submit a Health Record Form to the local authorities for any disembarking crewmembers together with the application.
- If the crewmember is reported to be in good health condition and health authorities' boarding inspection confirms so:
 - in case 14 days have elapsed since the ship departed the last foreign port, they can disembark the vessel without restriction or isolation.
 - in case it has been less than 14 days, the crewmember should be quarantined upon disembarkation until 14 days have elapsed since the ship departed the last foreign port, either at home or at a designated place for observation in line with requirement of the local authorities.
- If the crewmember shows any suspected symptoms, then the crew change should be suspended immediately, and virus prevention and control protocols shall be followed.
- If the crewmember is found to be asymptomatically infected, the prevailing protocol made by the relevant authorities shall be followed.
- Apart from the above Chinese crew change procedures, promulgated in recent notices, MOT will:

• continue to suspend crew changes of foreign national crew members on foreign flagged ships in Chinese ports.

No cruise vessel are allowed. No shore leave. The local agent at some ports are only allowed to board during clearing of vessel and carry out the key meeting, further assistance by agent will continue in a remote way.

There is a ban on any type of gathering and the government imposed closing of mosques throughout the territory.

Air links are suspended except on aircraft transporting cargoes.

Tourists who still remain on the island are advised to leave.

March 31, 2020, the government announced the suspension of international charter and commercial flights for a period of 30 days. Only international connecting flights passing to the island are permitted for the departure of foreigners.

Mandatory quarantine has not been announced or decreed, but it did decide to close schools and banned 7- inter-province transportation and public events. Some neighbourhoods are isolated due to the quantity of Apr confirm cases.

The measures adopted do not affect the arrival of cargo ships but preventive actions indicated in the National Plan will be taken, the protocol start prior the arrival of the vessel which consist on verified the last port of call, an interview with the Master with the support of the local bodies of the International Health Control following the provisions of the World Health Organization (WHO). Authorities must be notified previously in case of any crew member contagion on board. Extra measures with the corresponding protective equipment for pilots, customs and immigrations officer and other visitors are applied.

The Directive provides that all passengers in categories 1 and 2 will be directed to the doctor's airport office whereas at ports self-isolation will be limited to cabins.

Given the above any passengers / crew arriving from Italy will not be disembarked unless the 14 day period has passed, irrespective of any sign of symptoms. No directive or law has been issued by the Authorities with respect to "detaining" a vessel. Although a vessel may be cleared in (given that no physical contact is required to clear her in) the crew / passengers arriving from countries in categories 1 and 2 will not be permitted to disembark unless the measures contained in the directive are complied with. Once the 14 days have passed then the crew / passengers can be disembarked.

Please also note that agents have also been requested to provide a questionnaire to crew and passengers for completion prior to entry and submission the Authorities.

All borders with the Turkish occupied territory of Cyprus have closed until further notice.

As of 16 March 2020 (18:00 hours) until 30 April 2020, entry into Cyprus will only be permitted to citizens – regardless of nationality – who fall into the following categories provided that they hold a medical certificate confirming that they are free of the virus (issued within 4 days prior to the date of travel). Such certificate may only be obtained from designated centres in each country. Furthermore, upon arrival to Cyprus such persons will be quarantined for a period of 14 days in government quarantine facilities. It should be noted however, that practical difficulties in many countries are inhibiting the issuing of the required medical certificates thereby making travelling to Cyprus almost impossible.

- Cypriot citizens.
- Legal residents in the Republic of Cyprus.
- European nationals or third-country nationals working in the Republic.
- Nationals of countries who are in a designated diplomatic service or mission under bilateral or international conventions.
- Individual cases of European nationals or third-country nationals for unavoidable professional obligations, provided that the relevant authorization has been obtained from the competent Ministry.
- European or third country citizens attending educational institutions in the Republic of Cyprus.

Courts are permitting entry to their premises for urgent matters only and most hearings have been postponed.

All surveyors and agents have been advised by the Cyprus Ports Authority that they are not permitted to go

onboard vessels if they can carry out their work electronically (e.g. dealing with forms). Those who must attend onboard (e.g. for loading/discharge operations, taking samples etc) must do so only once the Master confirms in writing to the relevant port authority that the crew will be isolated and kept away from those going onboard.

No crew changes are permitted (embarkation / disembarkation) within the territorial waters of the Republic of Cyprus.

After 03:00 hours on 21 March 2020, Cyprus will come under a "flights shut down" mode for 14 days, although empty flights shall continue so that persons wishing to leave Cyprus may depart.

It is important to note, that the logistical supply chain is still open with no trading restrictions. As such, as far as that is concerned, it is business as normal.

Mar 25 March: The port of Esbjerg reports challenges with storage places, as loads of goods get delivered to port, however that some ships are delayed or postponed. The large number of goods, could be do the suppliers fear, that their goods cannot be delivered to port.

There are challenges to get people off the vessels from anchorage, and taken to hospital. However, so far with our involvement we succeed to get this done, with the assistance of the authorities.

Denmark

Most of activities have significantly scaled down, while the restricted movement of people within the country has been limited. Djibouti ports are opened and operate as usual, however the activities within ports have reduced. Once vessels arrive in Djibouti waters they remain at Anchorage until all crews on board are tested for COVID-19 by local health officers, and free pratique granted by same quarantine officers, after which the vessel is allowed to berth subject to berths availability. Once the vessels berth alongside port piers/berths, shore people (stevedore, surveyors, agents etc.) are only allowed to board the vessels when they are in facial masks, medical gloves, and goggles. Crews are not subjected to any discrimination and are treated with dignity and respect, although for now they are not allowed to be disembarked for treatment ashore. Crew change is also prevented at the moment as the government has suspended international flights (arrivals and departures) since March the 18th 2020 until further notice.

16 March: all travel to and from China is banned. Arriving passengers must complete a health declaration form and be screened for elevated body temperature. Anyone showing flu-like symptoms or who has been to an affected area in the past 14 days may be placed in 14-day home quarantine.

All agents of the vessel shall ensure that this information regarding possible prosecution for incorrect declaration is clearly informed to the vessel before its arrival at Indian ports

- Vessels arriving from ports of infected countries identified for mandatory quarantine and travel ban by MoHFW, Govt. of India before 14 days of departure from the infected port, or having seafarers embarked on the vessel who have been in infected regions within 14 days of arrival at any Indian port shall need to comply with additional measures. The updated list of infected countries may be obtained from the website of MoHFW, Govt. of India.

Kuwaiti Ports Authority announce that due to the recent increase in cases in Iran, the Kuwait port authorities have suspended all vessel movements from Iran for vessel calling Kuwait with immediate effect until further notice.

Kuwaiti Ministry of Communications (MOC) have informed all agents that as part of efforts to prevent the spread of COVID-19, Kuwaiti ports are prohibited from receiving foreign ships arriving from/ departing to the following countries in addition to closing all Maritime ports and banning all arrivals from any Nationality during the past two weeks from the above countries until further notice: Republic of Korea, Italy, Thailand, Singapore and Japan as well as the Peoples Republic of China and Hong Kong.

The Ministry of Communications have further advised that in order to maintain efficient trade, ships carrying goods from the Republic of Korea, Italy, Thailand, Singapore, Japan, Peoples republic of China and Hong Kong will be allowed to berth with the emphasis of prohibiting direct contact with the crew and preventing them from disembarking from the ship. The period they have specified is two weeks of their departure from the affected ports.

With effect from 6 March, The Ministry of Health in Kuwait has imposed a ban on travelers arriving from, or who have visited in the last two weeks, the countries listed below: Apr

This has been extended to 25 April. Curfew hours have been extended to end at 6am

Maritime navigation and normal operations at all Oil Terminals (Mina Al Ahmadi & Mina Abdulla) and

Commercial ports (Shuwaikh and Shuaiba) will continue as usual without any hindrance.

Ministry of Communications advise that agents are required to provide in addition the usually required documentation before arrival:

- a copy of the ships' logbook for the last 30 working days in English
 a copy of port clearance for the last 10 ports where cargo operations were carried out

13 March: Portuguese Government issue a statement informing that all passenger vessels will not be authorized to disembark any guests/crewmembers/staff. Licenses to go ashore also will not be granted.

Exception is made to Portuguese Citizens living in Portugal wishing to debark at our ports. Cruise vessels still may call Portuguese ports and to carry on provisions, fresh water and other supplies, as well as to perform bunkering operations.

All vessel crews are not allowed to leave the vessel while the vessel is in port. However, all seaport operations are ongoing within Liberia such as:

- 1. Disembarkation of stowaway from vessels
- 2. Disembarkation of Sick Crew Members
- 3. Loading and offloading of vessels operations

As of 16th March 2020, Libyan Authorities announced that due to the ongoing coronavirus (COVID-19) pandemic all air, ground and maritime Libyan borders will be closed for 3 weeks (with potential extension). If a vessel is calls to Libya from a country that has recorded COVID-19 cases, the vessel will go into

quarantine for 14 days at anchorage. The quarantine period starts to count from the date the vessel sailed from previous port of call. Thereafter, it will undergo an inspection by the Health Ministry. If it is found "clean", it will then be permitted to enter the port.

The courts in Libya have postponed most cases until June and only urgent matters are being dealt with.

25 March: GAC reports:

- It is banned to embark ships arriving at any Libyan port or oil platforms to avoid any direct contact with their crews. This ban applies to: pilot, representative of passports authority, customs representative, shipping agent, marine authority representative, shipment inspector, etc.
- Crews of foreign ships, ships, tugboats are banned to disembark at any Libyan port unless in urgent cases which are those cases approved by the director of health control office at the relevant port.
- The shipping agent should submit the following documents with the arrival notice:
 - List of last ten (10) ports that were entered (last ten (10) ports of call), including date of entry and exist for each port,
 - List of crew members with their embarking dates. Those who embarked during the last two weeks from the date of arrival should also be listed;
 - Declaration by the shipmaster that the ships is free from the symptoms or suspected symptoms of coronavirus.
- Administrative and technical procedures / formalities for each of the parties mentioned in Point (1) above over the radio and/or electronically.
- Berthing procedure will start once the health representative has verified the declaration made by the shipmaster as stated in subparagraph (2c) above. In case the health representative is not available the ship shall be granted the permission if the pilot agrees to permit it to enter using radio piloting onboard the assistant tugboat or radio piloting from the traffic control tower.
- Berthing operation will be done using at least (2) tugboats for safety.
- Remote pilotage will be carried out using radio and/or electronic telecommunications taking into consideration safety and security requirements.
- In case health control office exists at that port, their representative will be allowed onboard to ensure that the ship is free from any suspected case of coronavirus. He will not be allowed to embark unless he wears personal protective equipment including disposable overall, gloves,

- All shipping agents, operators of oil harbors of the National Oil Operations, the Libyan Ports Company, Misurata Free Zone, Towage, Salvage and Marine Services Company, General National Maritime Transport Company, shipowner companies should:
 - Provide Personal Protective Equipment PPE, including disposable overall, gloves, goggles, N95 mask, head cover, shoes cover and antiseptics approved by the National Center for Disease Control CDC,
 - Issue awareness circulations and guidelines for their staff members and follow up with international circulars on Coronavirus COVID-19.
- Shipmaster should, once the daily working hours are over, roll back the ship ladder and not to lift the ladder and not to roll it down until the next day when the handling operations start and upon an instruction by the relevant authority. In case he violates this instruction, he will be subjected to judicial actions

27 March: All ports are working normally and safely however due to the present Covid situation port authority issued new instruction with regards to port entry and direct contact with ship crew, as such please note the following:

- all vessel are allowed to berth upon arrival as usual provided availability of a berth, except vessel carrying automobiles and or livestock which should stay 14 day as quarantine,

Situation in courts – The Ministry of Justice ordered on 16/03/2020 p.m. the suspension until further notice of the activity in Moroccan courts. Only the hearings in way of emergency proceedings and those in relation to criminal pending matters are maintained. Thus the pending cases before commercial courts are suspended as well as the introduction of new proceedings.

27 March The state of sanitary urgency is in force until 20/04/2020 18 :00 it and may be reconducted as necessary. As from 06:00 p.m. till 06:00 a.m. people are not authorized to be outside unless for health emergency cases or for specific professional reasons. Movement between cities is not authorized as a matter of principle.

Ports are operating normally with specific prevention measures as detailed above.

Regarding surveyor's activity the surveyors are not allowed to access OCP terminal at Casablanca and Jorf Lasfar. As a consequence they can neither board ships berthed at OCP terminals. At Casablanca port the situation for surveyors is a bit confused. Depending on the terminal and also the agent the surveyor may or may not board the ships. There is however no restriction for surveyors as long as they remain on shore (to the exception mentioned above of OCP terminal).

13 March: Port Health requirements due to Corona Virus, all vessels must sent the required information before arrival at Beira Port:

- 1. Maritime Health Declaration
- 2. Crew list which is mentioned the countries where all crew members have embarked the vessel
- 3. List of 10 Port of Calls Before Beira
- 4. Yellow fever vaccination list
- 5. Declaration from Master confirming that all crew members are in good health conditions since from last Port of departure until arrival in Beira Port
- 6. Vaccination list

In case is verified any risk situation to Public Health and were confirmed that vessel is coming from infected Countries or crew members, Captains have to declare in Maritime declaration and inform all concerned before arrival of vessel, then will be analysed how long the vessel have taken from previous Port until Beira, at least vessel must have stand 14 days allowed from World Health Organisation, thence Port Health authorities will allow berthing of vessel and Port Health officer will be the first to be on board with appropriate machine to measure the temperature of all crew members, if not have been verified high fever temperature vessel will be allowed to work but all crew members will not be allowed to go ashore.

- All Vessels that have undertaken and international voyage, must apply for "Free Pratique" to Port Sanitary and Health Authorities, 24 to 48 hours prior to arriving the Limits of Port Maputo Marine Jurisdiction Area. Port Sanitary and Health Authorities and MPDC Port Authority/Harbour Master's Office, must be kept updated on any changes to the health status on board the vessel, whilst in Anchorage or while alongside the berth.
- Masters make accurate declarations of health and wellbeing of the crew, and if in doubt, consult with a medical practitioner to be arranged by the vessel agent. Masters unable to communicate in English stand the risk of not receiving services until a translator is arranged by the vessel agent. Any false declaration will be viewed in a serious light and reported to the MPDC Port Authority and Mozambican Health and Sanitary Officials for further action.
- Masters of all vessels are required to display the "Q" Flag if all onboard are healthy and Free Pratique has not been granted by Port Health means the master declares that all crew & personnel onboard are healthy and he/she requests Free Pratique. The Q Flag is to remain raised on the main mast until the vessel has been cleared by Port Health and Free Pratique has been granted.
- Duty Pilots are to make use of issued personal protective equipment (PPE), protective facial masks,

gloves and long sleeve shirt when boarding any vessel to protect themselves, even if the master has declared all onboard are healthy. The disposable PPE is to remove after every vessel and placed in a sealed plastic bag. The Pilot transport vehicle and the pilot boat will be provided with designated hazardous waste containers.

- All waste removal from Off Port Limit vessels and vessels at anchorages are to cease immediately until advised otherwise. Collection of Grey Waters, Sludge, etc., are included in the restriction.
- No waste including galley waste will be disposed of in Maputo and Matola Ports and in all Port Marine Jurisdiction Area. Galley waste will no longer be accepted at any ports and are to be incinerated on board the vessel.
- All Off Port Limit activities involving foreign vessels and crews to be suspended until further notice.

- Shore leave for Crews which vessels are alongside of any quay of Maputo and Matola Ports are not allowed. Visitors to vessels restricted to essential personnel only. Cancelled the emission of Shore Passes to Crew Members.
- Limited interaction between bunker operator and vessels permitted. Crew to ensure gloves are provided and used when handling mooring lines & all preventative precautions are upheld no crew changes permitted for bunker barges or vessel taking fuel from foreign countries.

Disinfection can be required: Afghanistan, Albania, Algeria, Andorra, Argentina, Armenia, Australia, Azerbaijan, Bahamas, Bahrain, Bangladesh, Barbados, Belarus, Benin, Bolivia, Bosnia and Herzegovina, Brazil, Brunei, Bulgaria, Burkina Faso, Butane, Cambodia, Cameroon, Canada, Central African Republic, Chile, Colombia, Costa Rica, Cote d'Ivoire, Croatia, Cuba, Cyprus, Czech, Dominican Republic, DR Congo, Ecuador, Egypt, Equatorial Guinea, Estonia, Eswatini, Ethiopia, Finland, Gabon, Gambia, Georgia, Ghana, Guatemala, Guyana, Honduras, Hungary, Iceland, India, Indonesia, Iraq, Ireland, Israel, Jamaica, Japan, Jordan, Kazakhstan, Kenya, Kuwait, Latvia, Liberia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Maldives, Malta, Mauritania, Mexico, Moldova, Monaco, Mongolia, Montenegro, Morocco, Namibia, Nepal, New Zealand, Nigeria, North Macedonia, Oman, Pakistan, Palestine, Panama, Paraguay, Peru, Philippines, Poland, Portugal, Qatar, Republic of Guinea, Republic of the Congo, Romania, Russia, Rwanda, San Marino, Saudi Arabia, Senegal, Serbia, Seychelles, Singapore, Slovakia, Slovenia, Somalia, South Africa, Sri Lanka, Sudan, Suriname, Tanzania, Thailand, Togo, Trinidad and Tobago, Tunisia, UAE, Ukraine, Uruguay, Uzbekistan, Vatican, Venezuela, Vietnam.

Only Group A countries are currently subject to the compulsory disinfection. Groups B) and C) as a

preliminary assumption only. The final decision on the need for disinfection will be taken by the Sanitary Authority for each particular vessel, depending on the actual epidemiological situation at the time of the decision.

After the disinfection on board all crew and passengers are subject to the medical check. Doctor must check crew temperature and general condition of the crew. If everything is good and no risks or sick persons found on board the Sanitary Doctor will confirm possibility to make Inward Clearance and obtain a full free pratique. After inward clearance formalities the vessel is allowed to perform cargo operations.

Kavkaz and Taman

- All vessels are subject to risk assessment by Health authorities on an individual basis.
- Focus is made on the 14-day incubation period and health condition of the crew.
- Shore leave may be limited for all foreign citizens (crew and passengers) at any port and any time.
- Screening on vessels arriving from any country is being conducted by Health authorities.
- Certificates of disinfection from the other countries are no longer accepted. As of 11 March 2020, no special restrictions or measures have been announced yet.

Taman Immigration authorities have temporarily restricted shore leaves for the following persons:

- Citizens of the People Republic of China, Republic of Korea, Italy and Iran arriving as crew members.
- Crew members foreign citizens, who visited ports of Italy, People Republic of China, Republic of Korea, and Iran during the last 14 days before arrival at Taman seaport.
- In daytime the vessels are visited by the sanitary services for identification of the crewmembers or passengers displaying symptoms compatible with the disease by temperature screening and examination. There is no screening during the night shifts.
- A list of the previous ten ports of call must be provided by Agents to Immigration authorities.
- Although there is no official requirement for a 14-day quarantine at anchorage, at the beginning of March a vessel coming from one of coronavirus-affected countries was not allowed to proceed for berthing until the expected incubation period of 14 days had expired

Tuapse

As of 20 March, all vessels arriving at Tuapse port are subject to a temperature screening of the crew members before commencement of the inward clearance formalities. There are no any other special

measures in force.

Kaliningrad

Crew members who arrived to Kaliningrad on the vessels that departed from High Risk countries / ports less than 14 days before their arrival to Kaliningrad are demanded to stay on board at all times while the vessel is berthed, NOT to attend shops, pharmacies and/or any public places, NOT to use public transport; to avoid contacts with others, to comply with hygiene and sanitary protection requirements (body temperature screening twice a day and keeping temperature records).

Authorized representatives of Shipowners and their agents are held responsible for enforcement of the above requirements.

Murmansk and Kandalaksha

Starting from 00.00 on 16.03.2020 and until further notice all crew members returning to Russia from other countries, especially from Norway, are to undergo a compulsory medical examination through the established procedure, social withdrawal / self-imposed isolation is not considered sufficient.

Starting from 00.00 on 17.03.2020 and until further notice, disembarkation and shore leave is prohibited to crew members having arrived on the vessels from foreign ports to the ports of Murmansk and Kandalaksha in cases where these vessels had left foreign ports less than 14 calendar days before they arrived to Murmansk / Kandalaksha. Harbor Masters of the ports are to take adequate measures to ensure implementation of the said requirements.

St Petersburg

As of 31 March, in St. Petersburg only people aged 65+ are recommended to stay home, no further restrictions have been announced yet. Ports are operating with limitations: the vessels' crew is not allowed to disembark while the vessel remains berthed at the ports; ship agents and surveyors are given access on board, always provided that they are properly protected by face masks and latex gloves.

Crew change is strictly prohibited for vessels arriving from outside the United Arab Emirates.

Abu Dhabi

Abu Dhabi Ports announced on 10 March that the following will take effect for three months:

- Crew changes are prohibited for vessels arriving from outside Abu Dhabi
- No shore leave is permitted, including berth and jetty unless in case of emergency and subject to approval from harbour master

Sharjah

Operational vessel movements are regular at all ports managed by Sharjah Ports Authority, but the following measures have been introduced for vessels at Sharjah ports to prevent/control the spread of COVID-19:

- Masters of all vessels to provide IMO health declaration duly signed and stamped 72 hours prior to the vessel's arrival, along with port required pre-arrival information including last 10 port of vessel call details and crew list.
- Upon arrival of vessel into port, all crew must undergo health screening at designated facility located in ports.
- If any crew indicate any symptoms of Covid 19, authorities will take necessary actions to quarantine and further medical interrogation.
- Until completion of health screening and clearance from Port (verbal approval) no crew is permitted to go onshore (except health screening) nor any personnel are permitted to go onboard vessels.

Since 17 March, the issue of all types of visas (tourist, visit visa, mission visa & seaman visa) for embarking/disembarking crew members has been suspended/deleted from the online immigration system.

As an additional precautionary measure, effective from today (19 March), the UAE has suspended entry of residency visa holders who are currently out of the country, for a renewable period of two weeks.

The issuance of all types of labour permits, including for drivers and domestic workers, has also been temporarily suspended until further notice. This decision excludes intra-corporate transfer permits and employment permits for Expo 2020.

No crew will be permitted to disembark for medical assistance. Any medical assistance should seek boarding of medical team from the Fujairah Port Medical Centre.

PORT MARINE CIRCULAR NO. 17 OF 2020 (23 March)

From 23 March 2020, 2359 hours, all short-term visitors, from anywhere in the world, will not be allowed to enter or transit through Singapore. MPA will apply these additional precautionary measures to all vessels calling at the Port of Singapore.

The Port of Singapore remains open for cargo operations and marine services, including shipyard repairs.

With the application of the additional precautionary measures, crew and passengers on short-term visits will not be allowed to disembark in Singapore for the time being. Crew change in Singapore is also disallowed for the time being.

The National Environment Agency's (NEA) Port Health requires all vessels arriving at Singapore to submit the Maritime Declaration of Health Form

PORT MARINE CIRCULAR NO. 18 OF 2020 (23 March)

MPA has taken the following enhanced measures for vessels arriving Singapore:

- All crew members are advised to take their temperature twice daily;
- All crew members are advised to maintain good hygiene in accommodation areas by cleaning frequently touched surfaces (e.g. desks, door handles, switches, telephones, etc).
- Shipmasters should isolate unwell crew and passengers.
- Shipmasters are required to report unwell crew/passengers to MPA and NEA's Port Health Office (PHO), and make the necessary arrangements to seek medical attention.
- Shipmasters should follow the National Environment Agency's (NEA) guidance for disinfecting common areas and rooms.

All suspected cases of COVID-19 crew/passengers will be assessed and/or tested for COVID-19. If there is a confirmed case of COVID-19 on board any vessel, PHO will quarantine the vessel at a designated anchorage or wharf, and in consultation with MOH provide the quarantine requirements for the crew and passengers. During the quarantine period, operations will not be allowed until the quarantine is lifted. If there is a need for any critical operation, PHO's approval will be required and all persons working onboard will be required to don the appropriate Personal Protective Equipment (PPE) which may include surgical

gowns, masks and gloves.

If there are no confirmed cases of COVID-19 on board vessels, there is no restriction on operations.

PORT MARINE CIRCULAR NO. 19 OF 2020 (27 March)

Singapore MPA have issued a Circular – CREW CHANGE FOR CARGO SHIPS UNDER SPECIAL CIRCUMSTANCES IN THE PORT OF SINGAPORE, TO MINIMISE RISK OF COMMUNITY SPREAD OF THE CORONAVIRUS DISEASE 2019 (COVID-19) IN SINGAPORE.

PORT MARINE CIRCULAR NO. 20 OF 2020 (3 April)

Singapore Ministry of Health (MOH) issued "Additional Measures to Minimise Further Spread of COVID-19". All business, social, or other activities that cannot be conducted through telecommuting from home will be suspended from 7 April 2020 to 4 May 2020 (inclusive); Essential Services and their related supply chains, as well as entities that form a part of the global supply chain, are exempted from the suspension.

The Port of Singapore will remain open for cargo operations and will continue to provide essential marine services including bunkering, ship stores and ship supplies.

- Refrigerated containers will be prioritised over non-essential exports.

The following will apply to the Container Terminals operated by the State-owned Transnet Port Terminals ("TPT"):

- Operating staff at Durban Container Terminal Pier 2 will be reduced to two berths;
- Durban Container Terminal Pier 1, Ngqura Container Terminal (Coega), Port Elizabeth Container Terminal and Cape Town Container Terminal will all operate a single berth operation with approximately half of the current staff complement;
- Cape Town Multi-Purpose Terminal will handle containers on a single berth;
- Durban Point will operate on a single berth for both containers and essential breakbulk goods;
- East London will not handle containers.

Essential goods and services will be prioritised as follows:

- Transhipments will be handled on an exception basis only with prior approval from TPT;
- Essential containers will be prioritised over non-essential containers;
- Each vessel will be required to provide a mandatory import evacuation plan prior to berthing;
- Containers must be cleared and assigned prior to berthing and it will remain the responsibility of the shipping lines to evacuate containers to a suitable facility within the free period;
- TPT reserves the right not to berth a vessel should these requirements not be met;

- Landside, inclusive of rail, will remain open but on a reduced resource basis;
- Acceptance of exports on rail will only be allowed if they can be physically exported through the applicable terminal;
- Refrigerated containers will be prioritised over non-essential exports;
- Import containers may be for cargo owners who have temporarily ceased operations during the lockdown period and therefore cannot receive the containers. In this case, it is the responsibility of the shipping line/freight forwarder to remove these containers to a depot or bonded warehouse within the free period.

In respect of the port of Durban:

- Port Control will be manned 24/7;
- Tugs and berthing staff will be reduced to 4 tugs and 4 gangs;
- All non-essential vessels that are not working cargo will be required to vacate the port by 22:00 local time tonight, 26 March 2020;
- Durban Container Terminal Pier 1 will be reduced to a single berth operation;
- Durban Container Terminal Pier 2 will be reduced to a two berth operation;
- Island View berths will be limited to IV2 or IV4, IV3 and IV6 or IV7;
- Point will have one berth available for essential cargo;
- Maydon Wharf berths will be limited to three being MW1/2, MW3/4 and MW5 with vessels to dock based on the essential goods list.
- All vessels are required to obtain Port Health clearance 72 hours prior to arrival, even if the previous port was another South African port;
- All vessels are required to obtain ISPS clearance prior to entering the port of Durban;

- No crew changes will be permitted, either in the port or off port limits ("OPL");
- All bridges, gangways, hand rails and doors must be regularly sanitised;
- The port will only allow disembarkation of returning South African citizens or permanent residents;
- Masters are to enforce strict gangway watches in port;
- No persons will be permitted to embark or disembark a vessel in port without approval from Port Health and Immigration Services;
- No shore leave will be permitted, save in exceptional circumstances, and approved by the South African Police Services and Immigration Services once the Harbour Master has been engaged;
- OPL operations for the supply of stores and equipment will only be permitted subject to the presentation to the Harbour Master, and his approval in writing, for each and every operation, of a Standard Operating Procedure, a comprehensive risk assessment of the operation and a detailed mitigation plan;
- No waste/slops, particularly galley waste and dunnage, may be removed from a vessel;
- No diving activities will be permitted save in an emergency and approved by the Harbour Master;
- Intensive measures are encouraged to be taken for hygiene control including but not limited to: washing of hands with soap and water for at least 20 seconds, use of an alcohol-based hand sanitiser containing at least 60% alcohol, sanitising of all work surfaces and self-isolation of any crew member when sick;
- Masters are encouraged to conduct relevant risk assessment/s and ensure that all crew members and persons boarding vessels wear the appropriate PPE;
- Masters are to discourage non-essential third parties from boarding their vessels;
- Bunkering to be approved in writing by the Harbour Master and such operations will be permitted subject to limited interaction between the bunker barge and the receiving vessels. The Masters of both the barge and the receiving vessel are to conduct a risk assessment to ensure adequate mitigation measures are put in place, particularly the donning of the correct PPE.

2 April: the South African Maritime Safety Authority, on behalf of the Department of Transport, informs all stakeholders that:

- ALL SOUTH AFRICAN PORTS REMAIN OPEN FOR PORT OPERATIONS
- CARGO OPERATIONS WILL CONTINUE IN ALL PORTS
- STEVEDORE OPERATIONS WILL CONTINUE IN ALL PORTS

ALL TYPES OF CARGO WILL BE ALLOWED TO BE LOADED AND OFF LOADED

The Spanish Government has implemented the "State of Alarm" – extendable depending on the evolution of the situation. Thus, the Spanish Government has established measures that can limit the circulation or presence of persons or vehicles at certain times and in certain places, amongst others. Port and logistic activities related to cargo vessels will continue.

However, personal interaction with personnel from local companies (agents, stevedores, suppliers, etc.) can have certain restrictions; all in views to prevent the spread of the COVID - 19 and guarantee the health of local personnel and crew on board.

All procedural deadlines, hearings and trials, as well as time bars, are suspended during the period of emergency declared back on 14 March 2020.

19 March: Port Authorities have informed that they have maintained with normality the operations that were previewed at their ports. Sanitary measures have been taken in order to minimize any risk of contagious by COVID -19. Crew changes are not allowed during the State Alarm period, at any of the Spanish Ports. If a change of crewmember has to be carried out due to medical reasons, immediate notification shall be made to agents so that the corresponding protocol be put in place by the Authorities.

9-Apr

23 March: Spain to prolong the State of Alarm two more weeks up and until 11 April 2020. There are restrictions to citizens' movement who have to remain confined in their homes. Border controls have been resumed with France and Portugal. International flights restricted and only Spanish residents and nationals are allowed in the country. Cruise and passenger ships are restricted.

Ports are operating, loading and discharge of goods is on-going. Stevedores and personnel attending on board vessels have to take basic precaution such as the use of masks and keep a safety distance of 1.5 mts from each person in contact.

9 April: State Bulletin Order TMA/330/2020 of 8 April extends the restriction of entry in Spanish ports of passenger ships and ro-ro ships providing regular services between Italy and Spain if they have embarked passengers in Italian ports, with the exception of drivers of traction heads of ro-ro cargo. Cruise vessels coming from any port are also prohibited.

It is expected that this new extension of the period of state of emergency will be agreed until 26 April.

In case that a vessel calling any Spanish port declares any ill crewmember with signs of COVID 19 or there is a suspicion of health alert, Port Authorities will follow a Technical Instruction where the vessel will be requested to immediately inform, through the Maritime Declaration of Health, to the Port Authority, the Harbour Master or the Maritime Port Traffic Control Centre.

Depending on the circumstances, and after a Health Inspection on board the vessel has been undertaken, the Port Authorities will decide if the vessel remains at anchorage or if allowed to berth at a designated berth.

In addition to the routine declaration, all arriving vessels are required to declare details of all ports of call within the past 14 days. Vessel masters are also required to provide a further health status on board declaration including health issues of crew and or flu like symptoms 12 hours prior to vessel arrival. Vessels are also required to report on their onboard health status to Port Control at their first point of contact Health declaration forms have also been provided to all local agents to be passed on to calling vessels and is required to be completed and submitted to authorities for consideration. It is mandatory for all crew and passengers landing ashore to fill out a Health Declaration Form for screening by health authorities. Any suspected patients or those with travel history to WHO categorized very high risk countries within the last 14 days may not be provided with the relevant medical clearances by authorities. Presently all port activities are ongoing as normal without any issues. Intermarc Services 31-16 March: Authorities have imposed a ban on embarking/disembarking crew, passengers and armed guards Sri Lanka Mar as from 1200 hrs LT (GMT + 5.5) today 16 March, and Crew shore leave too would not be permitted. These GAC restrictions have been imposed for 14 days and the situation would be reviewed thereafter. Effective Monday, March 16, cruise vessels are also banned.

7 April: St. Lucia's airports were closed to international passenger traffic until 5 April. From Tuesday 7 April, a 10-hour curfew will be in effect from 19:00 to 05:00. Essential services will be provided on Tuesday, Wednesday, Thursday and Saturday, from 07:00 - 16:00

The issuance of all types of labour permits, including for drivers and domestic workers, has also been temporarily suspended until further notice. This decision excludes intra-corporate transfer permits and employment permits for Expo 2020.

Crew embarkation/disembarkation and shore leave passes are strictly restricted. Offshore attendance at Khor Fakkan port has been temporarily suspended until further notice due to COVID-19.Boarding on any vessel by vessel agents/owners/representatives and surveyors will be permitted

Ship welfare visits will not be allowed unless in an emergency and the Marine Manager will decide whether the Port Welfare Chaplin may visit onboard or will arrange a convenient location for a confidential meeting.

Government agencies visiting the vessel will only be allowed in an emergency or after completing a Coronavirus questionnaire.

Vessels should report if they have on board crewmembers or passengers who are Chinese nationals or that have embarked in China, clearly specifying the date of embarkation.

It is reminded that the Health Declaration is an affidavit for which the Master of the ship is responsible. In case of misdeclaration, even if unintentional, the Master could face criminal charges for endangering the public health.

When the vessel has on board crewmembers or passengers who are Chinese nationals or that have embarked in China, then:

- 1. Before berthing, the Master will be requested to report whether there have been any crewmembers or passengers with fever during the last 48 hours. If affirmative, he will also be required to mention any other additional symptoms that may be present.
- 2. If the Surveillance Service concludes that there may be an infectious transmissible disease, the steps to be taken will be informed, and no access to the vessel will be granted until all requirements have been met.

17 March: Flights from Europe will be cancelled until further notice, effective from next Friday, 20th
25- March. People coming from countries defined as high-risk (i.e. China, South Korea, Iran, Singapore, Japan,
Mar Italy, Spain, France, Germany and United States), are obliged to remain in quarantine for a minimum of 14 days.

24 March: A new Presidential Decree was issued, with the following main aspects affecting the maritime industry:

- Passengers and crew members of cruise ships and commercial vessels coming from "high risk areas", as well as symptomatic ones from any origin port (presenting fever and one or more respiratory symptoms: cough, sore throat or respiratory difficulty), will not be allowed to disembark in the country.
- "High risk areas" are those areas determined by the World Health Organization Health in its daily updates, being included to date Spain, Italy, France, Germany, People's Republic of China, South Korea, Japan, Singapore and the Islamic Republic of Iran.
- As a consequence of the above, no crew shifts in our ports are allowed from said countries.
- For reasons of public order and health nature, all borders with Argentina and Brazil have been closed and the entrance of non-nationals coming from those countries will not be allowed, whatever the modality of transport.

- On 3/25/20, CBP sent guidance to agents informing them that "all foreign crew are being detained on board." - Any vessel that enters from a port from a high-risk country or with a potential COVID illness will be subject to a COTP Order keeping all crew aboard.
- Port State Control of foreign tankers continues as before the epidemic. The CG is exercising greater discretion to protect its personnel and crews for non-tank vessel PSC boardings.
- The State of California issued a Shelter in Place Order, with broad exceptions for many sectors, including transportation.
- On ships, agents are required to meet company hygiene protocols and confirm that they have not visited a high-risk country during the prior 14 days.
- USCG is reminding all vessel operators that Illness of a person onboard any vessel that may adversely affect the safety of a vessel or port facility is a hazardous condition per 33 CFR §160.216 and must be reported immediately to the USCG Captain of the Port (COTP). All cases of persons who exhibit symptoms consistent with COVID-19 must be reported to the COTP.

On March 23, the California Supreme Court issued an Order suspending all jury trials for 60 days. The status of other courts (and activities not covered by the Supreme Court Order) varies from county to county.Most in-court proceeding in all federal courts for the Northern, Eastern and Central Districts have been continued until May 1. USA – Delaware Bay The USCG now considers any ill person onboard a vessel, regardless of where they have been or who they have interacted with, who show symptoms of COVID-19 or other flu like illness to be a hazardous condition as per 33 CFR 160.216. Accordingly, the owner, agent, master, operator, or person in charge must immediately notify the nearest Coast Guard Sector Office (Captain of the Port – COTP) or Group Office. U.S. Flag commercial vessels are advised to report ill crewmembers in accordance with the requirements of each foreign port called upon. As the Master is likely to be the first person in charge aware of an ill crewmember, we strongly recommend the Master to immediately notify the nearest USCG COTP as per above, in addition to the U.S. CDC immediate reporting requirements.

Maritime Crew will be remanded to the vessels until further notice.

The Bar Pilots Dispatchers are asking the following one hour prior to pilot boarding: Does any crew member have symptoms of Coronavirus including a fever of 100.4 degrees or greater, cough, trouble breathing or body aches. Additionally have you complied with Captain of The Port, New Orleans, MSIB Volume XX issue:035, COVID-19 Vessel Precautions, Dated March 17, 2020?

Effective 0000 hours on March 17, 2020, CBP in conjunction with the United States Coast Guard have detained all foreign crew members arriving within 14 days from the following countries: Iran, China (excluding Hong Kong and Macau), United Kingdom, Ireland and European states within the Schengen Area: Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, and Switzerland.

USA – New York GAC CBP is requiring a guard presence to deter the absconding of detained crewmembers prior to inspection by 20- our officers on the 15th day from their last port call in the affected countries listed above. Every vessel that Mar arrives into the Port of New York/ Newark that fits the criteria listed above will be contacted by CBP to ensure a proper security plan is in place prior to the vessel's arrival.

From 1 April, USCG Houston-Galveston requires vessel to submit an NOA for arrival to the Houston-Galveston COTP zone will be required to complete and submit a COVID-19 attestation confirming:

(1) no crew/passengers have displayed COVID-19/flu-like symptoms over the past 14 days; and

(2) no crew/passengers have been to China (excluding Hong Kong, and Macau), Iran, the Schengen area, the United Kingdom, or the Republic of Ireland in the past 14 days.

Vessels will remain on the Not Cleared To Enter List until the attestation form is received and reviewed. The USCG review process will normally only occur during business hours, so it is advisable to be proactive by sending the attestation at the time of NOA submission or as soon as possible thereafter to avoid unnecessary delays.

CBP may, on a case-by-case basis, permit shore leave for limited reasons (e.g., humanitarian, shoreside business critical to the safe operation of the vessel, legal, medical, etc.). CBP is currently minimizing boarding activities and using local agents as intermediaries to exchange scanned copies of documents, signatures, etc. Crew sign-offs will continue to be reviewed and granted if the crewmember has direct and continuous travel out of the United States, the crewmember is not exhibiting symptoms of COVID-19, the crewmember has valid travel documents, and there is no other restriction on the crewmember's travel. Vessel must notify Coast Guard Boarding Teams of any crew illnesses prior to embarkation; vessel must notify Coast Guard Captain of the Port of any crewmember

Via notice issued on March 13, the Houston Pilots requested the following measures be taken prior to Pilot boarding:

- 1. Wipe down the bridge with a disinfectant (radars, pilot chair and piloting station, door handles, etc.);
- 2. Only essential members allowed on the Bridge at any time;
- 3. Personnel on bridge must sanitize hands;
- 4. No handshaking;
- 5. Crewmembers and Pilot should avoid touching their faces; and

6. Provide hand soap and/or hand sanitizer with paper towels.

Effective April 8, 2020, Port Houston will require non-contact temperature screenings of everyone entering Barbours Cut and Bayport Container Terminals restricted areas. Six (6) access points will be made available at each terminal. All other access points will remain closed until further notice.

The National Institute of Aquatic Spaces (INEA) INEA issued Circular No. 04 (Special Notice-02 COVID-19), dated 13 March 2020 – a number of preventive measures, among them: • Once the arrival notice is made, the Captain of the ship will be asked for the list of the last three (03) destination ports. • A sanitary inspection upon arrival of a ship to port. Venezuela Apr Instructions will be given to the Captain of the ship, so that during stay in Venezuelan waters the GlobalPandi Circular crews use protective masks. 16 March The Captain of the ship should be suggested to follow all the preventive measures that have been • made public to avoid contagion, such as the use of protective masks, antiseptic gel and frequent effective washing of hands.

The Circular No. 04 does not imply militarization nor delay in port activities.

Additionally, the INEA has suspended until further notice the "physical visit" to the ship by its personnel in order to verify the validity of the ship's documentation, what it will be now done via e-mail in coordination with ship agents.
